## Representative Cases :

1. Attorney Tian Jiangtao focuses on legal services for supply chains and supply chain finance, represented by factoring and financial leasing. He has successively provided permanent legal counsel services to core supply chain enterprises such as CMCC, CHNG, Foxconn Group, Jingbo Group, Lenovo Group, CNH Industrial Group, Newland Group, Great Wall Motor, Zhong'an Automobile, Yifeng Automobile, Jinan Construction Investment, and Xinjiang Communications Investment. He provides legal services for innovative business models in the domestic innovative factoring, leasing, and other supply chain finance sectors.
2. Attorney Tian focuses on providing legal services for disputes in the domestic factoring and supply chain fields. He has handled dozens of supply chain and supply chain finance dispute cases, including a 900 million RMB factoring contract dispute for Ping An Bank, a factoring contract dispute exceeding 100 million RMB for Foxconn Group, and bill dispute response cases for China Communications Construction Group, China Railway Construction Corporation, and Xinjiang Construction Engineering Group.
3. Attorney Tian focuses on research and policy formulation for the domestic supply chain and supply chain finance industry. He has participated in research and formulation work related to judicial and financial regulatory policies for factoring and supply chain finance by the Supreme People ' s Court and in Shanghai, Shenzhen, Chongqing, and other locations. He participated in the drafting of industry regulations such as the “ Several Provisions of Pudong New Area on Improving the Diversified Resolution Mechanism for Foreign-Related Commercial Disputes, ” the “ Compliance Management Measures for Financial Institutions, ” and the “ Notice on Regulating Supply Chain Finance Business and Guiding Supply Chain Information Service Institutions to Better Serve SME Financing, ” with several opinions being adopted by regulatory authorities. He has provided advisory opinions to financial regulatory departments in Jilin, Shaanxi, Nanchang, Xinjiang, and other regions.
4. Attorney Tian focuses on legal compliance training for the domestic supply chain finance industry. He launched the first online factoring series course in China — “ 12 Lectures on Factoring Compliance, ” which has been successively launched by bar associations in Shanghai, Yunnan, Guizhou, and other places, with over 6,000 lawyers participating in online learning. He contributed to the first group standard for supply chain finance compliance in China - the “ Operational Guidelines for Compliance Management of Commercial Factoring Companies. ” He regularly provides factoring and supply chain finance training and risk control assessments for domestic factoring, leasing, and other supply chain finance industry associations, local bar associations, and key enterprises.

5. Attorney Tian is dedicated to public welfare. While participating in the revision of the “ Charity Law, ” he learned about the numerous legal issues facing domestic operating charitable organizations. He specifically organized industry-specific research and, leveraging his professional expertise as a financial lawyer, innovatively proposed that Shanghai should prioritize the establishment of a charity asset management center alongside its strategy to build a financial center. He has conducted multiple seminars with civil affairs departments, notary offices, and other departments, and provides permanent legal counsel services to industry foundations such as the True Dream Foundation.
